Preamble

The Ministry of Environment & Forests, Govt. of India has selected three States for the pilot investment to be made under the proposed World Bank funded Integrated coastal Zone Management (ICZM) Project. Gujarat is one of the three States which are implementing Integrated Coastal Zone Management Project assisted by World Bank. The State of Gujarat is having longest and diversified coastline. Therefore proper and effective management of the coastal areas is essential requirement. Gujarat Ecology Commission (GEC) is working as State Project Management Unit (SPMU) to implement the ICZM project in the State on behalf of Forests & Environment Department, Govt. of Gujarat. One of the important objectives of the project is to build up the capacity of the State Government/ Organizations for management of marine and coastal areas of the State. Based on need assessment exercise as well as through consultation process, Gujarat Ecology Commission had prepared the capacity building plan to train functionaries of organizations/ departments concerned to the coastal and marine area management.

In order to achieve integrated management of coastal and marine area as envisaged in CRZ Notification, 2011, it is required to equip the functionaries of the stake holder organizations and departments with modern scientific, technical and managerial issues/ practices to deal with future challenges of the coastal zone management as well as to create sectorial development plan consistently.

Resolution:

After careful consideration, the State Government hereby pleased to assign the work of Capacity Building under Integrated Coastal Zone Management Project to the Gujarat Ecology Commission which may include preparation of training plan/ schedule and to manage/ organize the capacity building trainings within or outside State. GEC shall have to consult the respective Department as and when needed in the preparation & implementation of training modules. All the concerned Departments/ Organizations shall depute or relieve the officials, technical staffs in the public interest for the above mentioned purpose whenever Gujarat Ecology Commission decides for the same.
