**Preamble:**

For the smooth implementation of the "India : Integrated Coastal Zone Management ( ICZM) project " assisted by the World Bank through the Ministry of Environment and Forests, Government of India, and to avoid the administrative delay in the said project, the Government of Gujarat declared the Gujarat Ecology Commission as a State Nodal Agency. The Steering committee for guidance, monitoring, supervision and decision making of this project is also constituted.

The draft Procurement Strategy was prepared to empower various Implementing Agencies and State Project Management Units for the purpose of on various aspects of the projects, and achieving time bound progress was under consideration.

**Resolution:**

After careful consideration, the State Government is hereby pleased to decide as under:-

- a. To share only 10% ( instead of 12% and 50 % respectively for civil works and operation and maintenance cost) towards State Share for this project, which would be shared by the respective Implementing Agency from their own resources or through the budgetary provisions made by them in this regard.
- b. The Accountant General's audit shall be carried out for the entire funds under this project. Over and above the annual audit by Account General, concurrent pre-audit by internal auditors may also be done. In this regards auditing system that is followed in Rural Development Department may be studied and followed.
- c. A separate account in a Nationalized Bank shall be opened and maintained by the State Project Management Unit and each of the Implementing Agencies for the purpose of this project. The surplus / unutilized funds of this project, if any, shall have to be deposited by the SPMU/IA in the GSFS in accordance with the Finance Department circular No. JNV-1099-5233-A dated 31.12.1999.
- d. The Project Director, State Project Management Unit and each Implementing Agency shall be empowered for the expenses up to Rs. 30.0 lakhs and for with the Steering Committee constituted under the Chairmanship of the Principal Secretary ( F& ED ) ,however such delegation of powers would lie with Steering Committee.
